	Further information: Dusts are referred to as granular-biopersistent if, according to current knowledge, they are poorly soluble, have no substance-specific toxicity and do not chemically interact with structures of the organism and are not broken down in the lungs. For such dusts, the limit value is 3 mg/m3 for the respirable fraction, measured according to EN 481, and 10 mg/m3 for the inhalable fraction., National Institute for Occupational Safety and Health, Inert dusts, general dust value Inert dusts are dusts that, up to present knowledge, are not resorbed, nor lead to fibrogenic action in the lungs and that do not provoke disease symptoms. Because inert dusts can lead to mechanical irritation of the respiratory system, a limit value of 3 mg/m3 (alveolate dust), measured according to EN 481, and 10 mg/m3 for inhalable dust applies.
